## NOTIFICATION PROCEDURE FOR THIS PROTEST

So many have signed up for this event, I cannot contact each of you personally.

### To receive a text alert notification to assemble:

1. Install the app for iPhone(<http://apple.co/2o8cQAG>) or Android (<http://bit.ly/2nelpnw>)
2. Press 'Create New Account' to sign up
3. Enter the Indivisible Ventura invite code: 340-050-206
4. The notification will be sent to you from the co-host, Indivisible Ventura

### To receive an email notification

1. If you are already signed up to receive e-mails from Taffy Walker about GrassrootsVentura, you will get an email notification, and will need to be prepared to check your email frequently.
2. If you sign up for text notification (as above), you will also receive a text message.

### To receive a Message through Facebook

1. If you are signed up for Facebook at GrassrootsVentura group, I will send all my facebook friends a message. If you want to follow us on Facebook, send me a friend request. You will have to check on Facebook.

## *Nobody is above the law — USA must be able to investigate*

The firing of Special Counsel Mueller would be an attempt to quash the investigation of Trump and his campaign. This would make the firing an obstruction of justice, an impeachable offense, and probably a partial admission of guilt by POTUS.

Protestors will thus be standing up for American Justice, the Constitution's systems of checks and balances, and calling for the impeachment of DJT.

As soon as such news breaks, Rapid Resistance Protestors will begin to assemble at the corner of Telephone & Victoria, next to the Ventura County Government Center. Participants should start getting their signs made now.

No specific date can be posted now. However, as soon as the news of the firing is made public, we must be ready to assemble. If

the announcement is made before 2 PM on the east coast we will begin the protest at 5:00 PM local time. If the announcement is made later than 2 o'clock, we will convene at noon the following day.

We will update Facebook, Twitter, and will attempt to reach all of you as soon as possible the day the news is released.

**STAND AT READY, RESISTANCE TEAM!** Check your text messages and emails frequently for Mueller updates and to hear our call to action.

Participants should wear comfortable shoes, carry homemade signs and/or American flags, and be prepared to follow all laws. **Remember we are fueled by patriotism.** And we follow all laws. Parking available in the

adjacent parking lots and on side streets.
